Brochures & information given out to first time visitors to the FAO, or landowners dealing with Oil & Gas Companies for the first time. "Landowner Information Guide", "In-Brief: Landowners" and "Understanding the System" are most often given out.

Explained rights and gave out information about pipelines/flow lines and NEB pipelines - jurisdiction, compensation & rights pertaining to abandonment.

Explained rights to landowners who have received correspondence from companies seeking permission to survey or to conduct geophysical activity on their land.

Explained rights to landowners who have received notification that oil & gas activity is planned on adjacent property.

Discussed remedies with landowner who have not received lease rent payments from Oil and Gas Company when due. Also assisted landowners who received overdue notices and/or demand letters from The Surveyor of Taxes advising that property tax was overdue on oil and gas company leases on their land.

#### F. RECOMMMENDATIONS FOR IMPROVEMENTS TO THE PROGRAM

Section F is a separate document provided to the Management Committee at the option of the Service Provider and is not required as part of the Quarterly Report.

During this reporting period 35 ROW, 2 Riser Site, 1 Access Road and 2 Wellsite Lease documents were downloaded from the SRB.

With the decline in gas and oil prices, several oil and gas companies have gone into receivership. A growing number of landowners have to deal with oil and gas facilities on their property, for which they are now not receiving compensation, plus overgrown and unmaintained well sites and subsidence in pipeline rights of way. Landowners, who have multiple well sites and/or pipelines on their land, are expressing that the administrative burden is getting to be very heavy, and when they are not being paid the rent they are due, feel adamant that they cannot afford to have oil and gas activity on their land going forward. There has been little intervention from government and the situation does not appear to have triggered the Orphan Site Fund to date.

Many rural landowners are confused by notices for delinquent property taxes on oil and gas wells on their property. Collection letters are being sent out to some landowners, causing them to be fearful that their land is in jeopardy of going into forfeiture. Some landowners have paid these delinquent taxes, and we recommend measures be initiated by the Ministry of Finance to repay the landowners who have made these payments in error.

Another result of the economic downturn is that some landowners have found out, when applying for a loan, that liens have been put on their property from oilfield service firms that have not been paid by the oil company. We recommend that the Registrar should not accept liens unless they are very clear and specific about what legal interest in the land the lien is against. Also, if the subject of the lien is not registered on title then the company should be barred from filing the lien.
